## **Participant Information Sheet (Focus group)**

### Title of research project

The Lighthouse Program: Evaluating the effectiveness of a stakeholder-informed online training programme for parents, carers and supporters of 10–13-year-olds with unmet mental health needs in rural, regional and remote settings.

#### Introduction

I am Professor John Hurley of the Faculty of Health at Southern Cross University (SCU). I am working on this research project with Professor Marie Hutchinson, Professor Brenda Happell, Associate Professor Jacqui Yoxall of SCU, and Professor Bindi Bennett of Federation University. Together we are conducting a research project to further co design and refine an existing education programme. This digital education programme aims to enhance parent, carer, or supporter capabilities in responding to unmet mental health needs of rural or regional 10–13-year-old children in their care.

#### What is this research about?

Mental health services for children living outside of metropolitan settings are inadequate, with complex barriers challenging prompt access to appropriate services. These barriers include extended wait times for counselling, travel and financial costs, knowledge gaps on mental health generally, and how to access services more specifically. We believe offering relevant and practical training to parents, carers and supporters of children experiencing mental health and behavioural challenges will be helpful to the children, and those who are caring for them. We previously ran a successful education programme for parents, carers and supporters of teenagers in regional settings. We now seek to refine that programme for digital delivery to parents of a younger cohort through eliciting the experiences of rural and regional parents/supporters of children aged 10-13.

#### What does this research involve?

Two separate online focus groups, one for parents and carers and the other for youth mental health clinicians and primary school teachers, will be held. It is anticipated each focus group will run for approximately 60-90 minutes. Rural and regional parents/supporters of children aged 10-13 will be asked to share their experiences of perceived needs, service deficits and what education would better support them. Headspace clinicians and rural and regional primary teachers will also be asked about their perceived needs. Both focus groups will examine the existing education programme and offer insights from their experiences as to how it can be altered and/or refined for this regional and rural younger age group.

Participation is voluntary and participants can withdraw at any time during the study and their data will be removed. Participants will be offered a \$50.00 grocery voucher to take part in the focus group.

With your permission, the focus groups will be audio-recorded, but you can ask for the recording to be paused at any time if you wish to say something "off the record".

Informed by the findings of this study, a second study will then be conducted which will evaluate the effectiveness of the education programme, and the lived experiences of those who took part in it.

#### What are the risks associated with this research?

One potential low-level risk has been identified for the research project. This risk is unlikely and will be managed as highlighted below:

- 1. Participant's emotional discomfort during the focus group Participation is voluntary, and participants can withdraw at any time. If a participant opts out of the study, their data will be removed. This will be explained to all participants before the commencement of the study.
- 2. At the end of the focus group, participants will be given the time to express any additional concerns or thoughts. All participants will be given information, including web addresses and telephone numbers of free counselling services they can utilize if they become distressed by topics raised during the groups.
